

Turners Trucks & Machinery “Win Your Seller Fees Back” Promotion

Promoter: Turners Group (NZ) Limited (“Turners”).

Promotion Period: 21 – 30 September (inclusive).

Eligible Channels: Any Turners branch in New Zealand offering trucks or machinery sales.

1. Eligibility

1.1 Entry is open to any individual or business entity (“Vendor”) who **lists and successfully sells** a truck or machinery asset through Turners during the Promotion Period.

1.2 Vendors must comply with all standard Turners selling terms.

1.3 Employees of Turners may enter **only if** they are genuine private vendors and not acting in their capacity as employees.

2. How to Enter

2.1 Every qualifying asset listed with a reserve reduction of 20% or more, and sold by a Vendor within the Promotion Period automatically becomes **one entry** into the prize draw.

2.2 No additional purchase or fee is required beyond normal seller fees, in accordance with NZ law requiring entry to be free apart from usual prices.

2.3 Entries cannot be transferred or exchanged.

3. Prize

3.1 There is one (1) prize that will be awarded. The prize is a rebate of the commission payable by the winning Vendor on the eligible auction transaction.

3.2 The value of the prize will vary depending on the commission payable by the winning Vendor under their applicable Vendor Agreement (including any General Auction Terms (GAT) or Auction Trading Services (ATS) agreement).

3.3 The rebate will be equal to the commission that would otherwise be payable by the winning Vendor, up to a maximum of \$2,500 plus GST. Any commission amount above \$2,500 plus GST remains payable by the Vendor.

3.4 The prize is not transferable, exchangeable, or redeemable for cash.

4. Prize Draw & Winner Notification

4.1 A **random draw** will be conducted by Turners on **5 October 2026**.

4.2 Winners will be notified by their local branch by **7 October 2026**.

4.3 The draw must be based entirely on chance to comply with NZ “sales promotion scheme” rules under the Gambling Act.

4.4 Turners’ decision is final and no correspondence will be entered into.

5. Conditions of Prize Acceptance

5.1 The winner must have fully complied with the standard Turners selling process.

5.2 Turners may request proof of identity or documentation verifying the entry.

5.3 If the winner cannot be contacted by 7 October 2026 using details provided, Turners may redraw the prize.

6. Liability

6.1 Turners is not responsible for:

- technical issues delaying sale processing,
- incomplete or inaccurate seller information,
- events outside Turners' control.

6.2 Turners will honour the prize exactly as described and will not make misleading representations, as required under the Fair Trading Act.

7. Privacy

7.1 Personal information collected for the purposes of running this promotion will be handled in accordance with the **Privacy Act 2020**, which grants entrants rights of access and correction.

7.2 Winner names may be shared internally with relevant branches for notification purposes.

8. General

8.1 Conditions cannot be changed once the promotion has begun, per NZ sales promotion rules.

8.2 Turners reserves the right to verify eligibility and disqualify any entrant who breaches these terms.

8.3 Entry constitutes acceptance of these Terms & Conditions.
